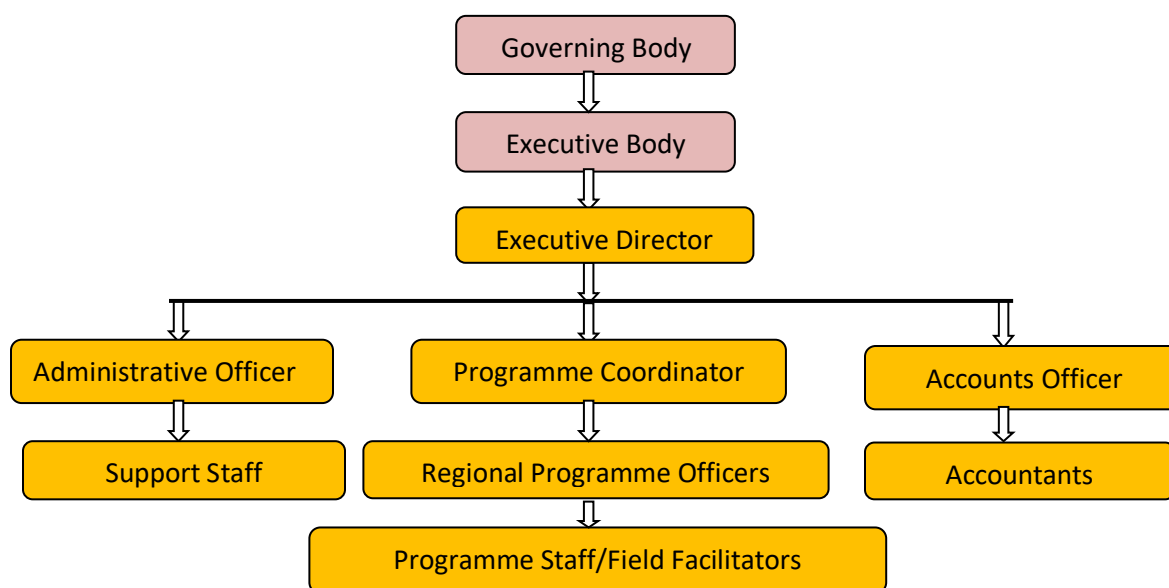

## **PROMOTING ECONOMIC SELF RELIANCE AMONG THE UNDER-PRIVILEGED**

### **JAN SHIKSHAN SANSTHAN (JSS)**

Jan Shikshan Sansthan aims to provide vocational training to non-literates, neo-literates as well as school drop-outs in rural regions by identifying skills that have a relevant market in that region. Over two-thirds of India's population comprises rural citizens. The objective of JSS is to uplift this rural population economically by imparting essential skills training, thereby enabling local trades to grow and creating new opportunities for the natives of the region.



The mandate of the scheme is to provide vocational skills in non-formal mode to non-literate, neo-literates, persons with rudimentary level of education up to 8th and school drop-outs up to 12th standard in the age group of 15-45 years. The priority groups are women, SC, ST, minorities and other backward sections of the society. JSSs are reaching to the

unreached areas to cater the needs of the poorest of the poor. They work at the door step of the beneficiaries with a minimum infrastructure and resources.

The Jan Shikshan Sansthan have special place in the field of education due to its people centric quality vocational and technical education at a very low cost. The services of JSS are accessible to all and the staffs of JSS reach out to their clientele groups by setting up sub centers in the heart of the slum or in remote rural areas. They are different from other vocational training institutions as they offer quality vocational skills and technical knowledge at such a low cost; provide need based and literacy-linked vocational training to reach out to the clientele in their areas unlike other institutions which the clientele has to



access whether near or far; offer a multi-faceted skill-knowledge-awareness enhancement and outlook formation trainings and inputs and empowerment-oriented interventions in respect of social, economic and health status improvement of women and adolescent. The JSS promotes:

- Polyvalent approach takes into account; learning needs, convenience of place and time of learners and trainers.
- Course content, duration, methods, instructional arrangements and financial (CSR supported / Fee based trainings)
- Livelihood cell to be encouraged the beneficiaries for self and wage employment and linkages with national / state portal for promotion of employment and job melas etc.
- Courses having NSQF Compliant which has production, service and IT oriented.
- Life Enrichment Education part of Skill training programme. Digital Literacy and life skills are also incorporated across the course curriculum.
- Methodology of teaching includes theory, practical. Livelihood experience / apprenticeship, systematic evidence based internal assessment system, online certification, common branding.
- Training of trainers through National Skill Training Institutes
- Evaluation includes concurrent and terminal.
- Feed-back/success story Performa developed

### **Different Skill Development Trades under JSS during 2021-22**

- Self Employed Tailor

During the year 1800 nos. of beneficiaries were trained in above trades. Most of the beneficiaries are young women hailing from rural SC/ST & BPL families within the age group of (15-45) years. The said project has been a crucial link between the semi and neo literates hailing from rural areas with no proper source of income and not capable of mobilizing institutional finance for starting their own source. This project has created a platform for their economic self-reliance and social empowerment.

## **SKILL DEVELOPMENT TRAINING**

Skill Development Training of unemployed educated youths is one of the most important issues as it helps them tap into their capabilities, develop real-life skills, and prepare themselves to be successful in the careers of their choice. Skill-based learning improves employability and helps the youth earn more. Furthermore, it improves the economy of a country and promotes its financial growth. India faces a huge skill development challenge. There is huge a gap exist in skill development sector which needs to be filled in which is basic factor of industrial growth. It is estimated that around 50 to 70 million jobs will be created in India over the next five years and about 75 to 90 percent of these will require some vocational training. For India's demographic transformation to be considered a "dividend," the youth will need to acquire necessary knowledge and skills to contribute towards nation-building. Development programmes and their allied industries should develop the capability to cross-train the youth and build a culture of learning.



Taking into account the above factor our organization has been taking special initiative for skill development of unemployed youths the above issues, JJJS has been promoting employment linked skill training programmes in agriculture & allied sectors including dairy, poultry, bee keeping, organic farming, natural farming, Tailoring, Rixin Bag making, Food Processing, Mobile Repairing, Agarbati making etc. in Rayagada & Subarnapur district of Odisha. Through these activities the unemployed youths from backward communities including some of PTGs are being provided skill training and back up assistance for their gainful employment. 480 nos. of unemployed youths especially ladies were trained during the year in various trades as above and then engaged in the production center managed by the organization to gain such practical knowledge and some seed money for starting their own production units.



## **PROMOTION OF SHG & MED THROUGH NABARD**

Self Help Groups (SHGs) are informal groups that consist of people who face similar problems. These people come together to form a group to overcome their common problems to improve their standard of

living. They are mostly from a similar socio-economic background and are involved in undertaking small savings amongst themselves in a bank. This amount acts as the fund for the SHGs and is used to provide loans to its members. It is a vital tool to alleviate people from below the poverty line and improve social status through the promotion of self-employment.

During the year efforts were made to strengthen the existing SHGs by linking them with various skill training programmes and assisting them to have their micro enterprises. Also 12 nos. of Capacity Building Programmes were organized in Puri & Subarnapur districts of Odisha. Till the end of the reporting year JJJS has 440 nos. of active SHGs involving 4694 nos. of poor and ambitious ladies hailing from 4845 villages of Puri & Subarnapur district.

Efforts are being made for convergence of welfare schemes of Govt. to further enhance their earning potential and quality of living.

## **INITIATIVE TO REDUCE THE IMPACT OF DRUG ABUSE**

### **INTEGRATED REHABILITATION CENTER FOR ADDICTS:**

While most people think that addicts have a choice, in reality, an addict needs professional help because it is a chronic disorder. Drug addiction not only affects the substance abuser but also impacts families. They go through mental stress, face social consequences, and are pushed into financial crisis. June 26 is observed as the International Day against Drug Abuse and Illicit Trafficking to promote a society free of drug abuse. Individuals, communities and various organizations in the world join hands to raise awareness. To make a positive difference you can contribute to this fight against drug addiction, be a volunteer or donate to nonprofits working to curb drug addiction and help addicts rebuild their lives.

To reduce the impact of drug abuse and drug demand in the society Government is adopting different measures/strategies from time to time control the drug abuse and trafficking. Also the Govt. of India has framed some laws and time & again adopting various other measures.

JJJS has also been lending its helping hand by running a 10 Bedded Integrated Rehabilitation Center for Addicts (IRCA) at Paralakhemundi under Gajapati district of Odisha since last seven years to control drug abuse and related social issues. Since long our organization has been making sincere efforts to stop wide spread drug abuse and create general consciousness among the public through awareness programmes. The said center has been providing various services including awareness generation against drug abuse, identification of addicts, motivational counseling for treatment, in house and out house treatment of the addicts for detoxification, counseling and rehabilitation services, outreach services to deal with the clients living in unreachable areas of the district, after care services to the recovered clients for maintaining sobriety, re-integration of recovered addicts with the main stream of the society etc. During the year on report more than 62 numbers of addicts have been treated and most of them are now maintaining drug free sober living.



This initiative has been useful in saving the lives and careers of hundreds of drug addicts by making them drug free & reintegrating them with the main stream of the society. Scores of such families have been saved of financial and social bankruptcy at the same time reducing the law & order problems and maintaining the social harmony.

## **EFFORTS FOR REHABILITATION OF DISADVANTAGED SECTIONS OF THE SOCIETY**

### **i) HOME FOR SENIOR CITIZENS**

The elderly population in India is one of the fastest-growing in the world. At present India is considered as the second-largest global population of ageing citizens. It is expected that the present number will further increase by 2050. Nevertheless, India lacks the basic infrastructure and expertise to support the health and welfare of the elderly. According to various surveys across the country for most Indian senior citizens the biggest concerns that are prevailing are Healthcare costs, lack of financial support and seclusion. In addition to this most of the aged people are not accorded the dignity of care they deserve. Today's young generation are found to be in love with the urban living conditions and adopting nuclear families away from their parents. The aged parents have no option but to stay back at ancestral homes where they live a lonely life. Hence the elderly are being exposed to emotional, physical and financial insecurity endangering their living. Negligence, torture, discrimination etc. is very common now and being reported every day in newspapers. There are innumerable such cases remaining unreported from the rural areas leading to deaths due to negligence, starvation. It has now become very common.

With a view to address this critical issues being faced by these indigent senior citizens who are without any social and economic support, our organization has been managing a Senior Citizen's Home (Mixed Gender) one at Sonepur under Subarnapur district of Odisha. The center has 25 nos. of mixed gender beneficiaries. Apart from shelter other services like boarding healthcare, recreational and assistance for productive activities is being extended to the beneficiaries. Also facilities are there for engaging them in productive activities to keep them active and productive.

The said Home has been the destination for scores of such helpless & distressed elders who are neglected, deserted and exploited by their near and dear ones round the clock.

### **ii) SENIOR CITIZENS HOME FOR 50 ELDERLY WOMEN**

As we are aware aged women especially widows face uphill task of living in our society normally as they often face multiple problems due to illiteracy, malnourishment, abuse, ill-health, lack of housing and exclusion from economic benefits. Senior citizens in India face a number of challenges, but the situation is worse in case of elderly women. Elderly women face



bias and discrimination throughout their life but they never raise their voice against it.

In order to address the issues of these disadvantaged sections of the society and to take care of social, emotional well-being, our organization has been running a Senior Citizen's Home for elderly women at Sonapur under Subarnapur district with its own resources. 50 nos. of destitute senior citizens including widows are being provided with residential rehabilitation service which includes lodging, boarding, healthcare, recreational and assistance for productive activities

Efforts are on to avail grant-in-aid from Govt. of India, Ministry of Social Justice & Empowerment for the project.

### **(iii) PHYSIOTHERAPY CLINIC**

While physiotherapy cannot stop the ageing process, it can help to reduce the impact that it has on seniors and their lives. Let's look at five benefits of physiotherapy for the elderly. Physiotherapy is a non-drug treatment for the elderly that works for injuries and conditions such as arthritis, joint pain, Parkinson's, and incontinence all while improving your strength and endurance. Physiotherapy is performed through movement, exercises, massages, manual therapy, and other methods, over medication and surgery. As an effective treatment for a plethora of conditions, physiotherapy can also help speed up the recovery time after surgery. In fact, physiotherapy exercises have been scientifically proven to be one of the most effective ways to cure pain and injuries. Older adult care is complex because it comes with multiple conditions requiring knowledge of many specialties. Older adults often develop conditions under musculoskeletal, cardiovascular and neurological conditions.



Considering all the positive impact of such treatment process our organization has been managing a Physiotherapy Clinic at Boudh of Odisha with assistance from the Social Security & Empowerment of Persons with Disability (SSEPD) Department. Govt. of Odisha under the scheme: State Action Plan for Senior Citizens. During the year (from December'2022 to March'2023) 172 no. of older persons with various medical problems have been treated free of cost. The project has been useful in providing relief to the senior citizens suffering from various ailments those are not addressed by the other form of treatment.

### **(iv) MOBILE MEDICARE UNIT/ MOBILE DISPENSARY**

Mobile dispensaries are that which provides health coverage to the people living in the remote and deep interior areas. These mobile dispensaries are functional on a regular basis. It facilitates to maintain "regular contacts" with the villagers and thus help in establishing "good rapport" with them. Also these units help the senior citizens as this type of dispensary moves and reaches to the people at



their door step to provide healthcare which is beneficial for the senior citizens considering their problems related to mobility and lack of interest by the family members to carry them to the hospital located in distant places. Hence Mobile Dispensary can help in addressing the healthcare issues of those living in far off places located in hilly areas and save innumerable lives.

Our organization after realizing the importance of such mobile dispensary, has been running three numbers of Mobile Medicare Unit/Mobile Dispensary in Boudh, Rayagada & Nayagarh districts of Odisha from its own resources since last 3 years. The project is being run with our own resources. During the year 2022-23 the project has provided healthcare to thousands of needy people in isolated pockets including senior citizens at their door step. The said project is very useful for the older persons from poor families.

### **(v) SWADHAR GREH**

India is also a powerful nation and famous worldwide for being the largest democracy in the world however, women backwardness is also very clear in the Indian society because of the social issues, problems and lots of restrictions against women. Women belong to the lower and middle class family suffers more than the women of higher class family. Women in the Indian society generally face problems of sex discrimination,

Women in difficult circumstances are often rendered homeless due to reasons such as family violence, social ostracism, human trafficking and alike. In order to provide them Shelter after being rescued from such stressful situations Shelter Home with integrated care & support services are desired.

To address the problems of these women and provide them rehabilitation services, Govt. of India, Ministry of Women & Child Development has been implementing the Scheme “Swadhar Greh”. The said scheme envisions a supportive institutional framework for women victims of difficult circumstances so that they could lead their life with dignity and conviction. It envisages that shelter, food, clothing, and health as well as economic and social security are assured for such women. It also envisions that the special needs of these women are properly taken care of and under no circumstances they should be left unattended or abandoned which could lead to their exploitation and desolation.

Our organization has been implementing this project since 2008-09 with assistance from Govt. of India, Ministry of Women & Child Development. The project is now located at Ranapalli, Block- Birmaharajpur of Subarnapur district. The center is running & at present giving shelter to 30nos. of such ladies living without social and economic support. They are being provided integrated services such as lodging, boarding, healthcare, clothing, recreational and legal &



emotional counseling, legal assistance along with skill training for their complete rehabilitation.

Besides the women, their dependent children below 14 years of age are also provided shelter with their mothers with provision of all the services including education to make them responsible citizen in the future.

**(vi) ONE STOP CENTRE (SAKHI)**

Due to the silence, stigma, and shame surrounding it, violence against women and girls (VAWG) is one of the most pervasive, ongoing, and severe human rights violations in our society today. As a result, the Indian government committed to ending all forms of violence against women.

Violence against women continues to be an obstacle to achieving equality, development, and peace as well as to the fulfillment of women's and girls' human rights. Overall, ending violence against women and girls is essential to achieving the Sustainable Development Goals (SDGs), which promise to "leave no one behind." Hence it is most important to address the issue with much more seriousness than before with strict measures in order to decrease rate of violence.



Taking into account the various issues the women affected by violence are facing, Govt. of India, Ministry of Women & Child Development has been running "One Stop Centres (OSCs)" which objects to support women affected by violence, in private and public spaces, within the family, community and at the workplace. Women facing physical, sexual, emotional, psychological and economic abuse, irrespective of age, class, caste, education status, marital status, race and culture will be facilitated with support and redressal. Aggrieved women facing any kind of violence due to attempted sexual harassment, sexual assault, domestic violence, trafficking, honor related crimes, acid attacks or witch-hunting who have reached out or been referred to the OSC will be provided with specialized services. Our organization has been managing a One Stop Centres in Rayagada district. Which started on 6<sup>th</sup> September'2019. The One Stop Centre, Rayagada provided service to 145 nos. of violence affected women during the year 2022-23.

## **(vii) CHILDREN'S HOME**

There are various factors that make Indian children vulnerable and exposed to risks. Some of these aspects are age, physical disabilities, lack of capability to defend themselves, illness, lack of education, lack of identity. All these issues lead the children into child marriage, child trafficking, missing and runaway children, child labor, children affected by civil unrest, child sexual abuse, dropouts and low literacy rates, malnutrition, feticide and HIV affected children.

In order to protect these children who are in need of immediate care & protection, our organization is managing a Children's Home at Sonapur with assistance from Women & Child Development Deptt., Govt. of Odisha. Under Mission Vatsalya Scheme of Ministry of Women Child Development, Govt. of India. At present the strength of children 50. These children are in need of care and protection and through the Children's Home being provided with institutional services for their rehabilitation. The services being provided to them include shelter, nutritious food as per the prescribed menu, healthcare, education, recreational and vocational training for their all-round capacity building.

The children are enrolled in the local formal schools for their education and a tutor is engaged at Home to follow up them and solve their problems. Yoga is being practiced to promote physical well-being and spirituality among the children. Also there is the provision of teaching song, art, music, dance in order to promote extracurricular activities and help to find out the hidden talent. Each year the children are being exposed to various competitions to groom their talents.





The Home which original belongs to District Administration has been handed over to the district administration with effect from 01.12.2022 as per the decision of the Govt. The said Home will now regarded as Govt. run Home.

### **viii) SPECIALIZED ADOPTION AGENCY (SAA)**

Adoption means the process through which the adopted child becomes the lawful child of his adoptive parents with all the rights, privileges and responsibilities that are attached to a biological child. The following fundamental principles shall govern adoptions of children from India, namely:-

- the child's best interests shall be of paramount consideration, while processing any adoption placement
- preference shall be given to place the child in adoption with Indian citizens and with due regard to the principle of placement of the child in his own socio-cultural environment, as far as possible
- all adoptions shall be registered on Child Adoption Resource Information and Guidance System and the confidentiality of the same shall be maintained by the Authority.

At present CARA (Central Adoption Resource Authority) one of the constituent projects of the Scheme “Mission Vatsalya”, Govt. of India, Ministry of Women & Child Development is promoting the adoption process in direct cooperation of SARA (State Adoption Resource Agency) & Specialized Adoption Agency (SAA). SAA facilitates the placement of orphaned, abandoned or surrendered children for adoption in accordance with the provisions of various guidelines for adoption issued from time to time, by the State Government, or the Central Adoption Resource Authority (CARA) and notified by the Central Government.



Our organization, Juba Jyoti Jubak Sangha has been recognized by Govt. Of Odisha, Women & Child Development Deptt. as SAA for Subarnapur district with effect from 09.02.2017. Our organization has been promoting adoption as per the guidelines set forth by CARA.

SAA is responsible for the care, protection and well-being of every child in its charge and shall cater to their health needs; emotional and psychological needs; educational and training needs; leisure and recreational activities; protection from any kind of abuse, neglect and exploitation; social mainstreaming and restoration or as the case may be and follow-up.

During the year 2 nos. of children have been present in the SAA out of which only one child has been restored to their legal parents and another one with special need is staying at present. Our organization is taking necessary steps for sensitization of the community regarding adoption and various rules governing the adoption to promote adoption.



## ix) SPECIAL SCHOOL FOR DISABLED

Disable children lack the ability to perform tasks like the normal children hence they need special caretaker for doing their daily tasks. When the issue of education of these children arise they face problems as they will need special teachers, aids and appliances, conducive environment etc. Therefore Government is taking steps for addressing this problem and Special School for disabled is one of the projects under DDRS Scheme. The main thrust of special education is to develop communication skills and other sensory abilities, with the end objective varying from acquiring daily living skills to integration in regular institutions of learning and society in general. Residential facilities is also extended to the beneficiaries under the project.

Our organization started such a school each at Boudh & Rayagada during the year with its own resources. 100 nos. of disabled children are enrolled in each of the above two schools and provided with education along with integrated care & protection services, extracurricular activities like sports, music, vocational training, yoga etc.

## (x) WELFARE OF PwDs

Disability is an important public health problem especially in developing countries like India. The problem will increase in future because of increase in trend of non-communicable diseases and change in age structure with an increase in life expectancy. The issues are different in developed and developing countries, and rehabilitation measures should be targeted according the needs of the disabled with community participation. In India, a majority of the disabled resides in rural areas where accessibility, availability, and utilization of rehabilitation services and its cost-effectiveness are the major issues to be considered. Research on disability burden, appropriate intervention strategies and their implementation to the present context in India is a big challenge.



Rehabilitation of the PwDs is one of the priority sectors of our organization and in the process has been actively extending integrated care and support to the PwDs by implementing the Community Based Rehabilitation Project in Boudh & Rayagada districts of Odisha. The major objective of **Community Based Rehabilitation (CBR)** is to ensure that people with disabilities are able to maximize their physical and mental abilities, have access to regular services and opportunities, and achieve full integration within their communities. During the year 245 nos. of disabled were benefited under the programme. They were provided rehabilitative services based on their individual requirement such as supply of aids & appliances, providing them pensions, vocational training, assisting in DRI Loan, Scholarship for the school & college students etc. Among them there are 32 nos. of Multiple Disable cases who were assisted as per their needs.

## **(xi) REHABILITATION OF TRANSGENDERS**

Transgender people have existed across all classes, races and castes. But their recognition has always come at a cost, with an added struggle. From access to social equality, social rights, education, jobs and so on, the transgender community has been victim to the dichotomous attitude of the society exhibited towards them; how they are simultaneously marginalized and revered. Particularly, in the field of jobs, transgender people have always had difficulties, one notch higher

Transgender / Hijras are officially recognized as a third gender generally live in a group away from the general people and live on begging and doing odd jobs. They are facing discrimination in the society and now the Govt. is taking steps for their rehabilitation.

Our organization through SSEPD sponsored Outsourcing Programme have worker for their welfare in Subarnapur, Boudh, Deogarh & Jharsuguda districts of Odisha. Presently we are maintaining a Home for the transgender Community at Boudh in which 20 nos. of TGs are staying. They are being provided with integrated care & support including shelter, food, clothes, Healthcare, Recreation & Vocational training for their economic rehabilitation.

## **(xii) REHABILITATION OF BEGGARS**

Associated with the problems of poverty and unemployment is the problem of beggary which is a social problem of great magnitude and grave concern in developing countries. Begging is a problem for society in as much as a large number of beggars means non utilization of available human resources and drag upon the existing resources of the society. In spite of its rapid economic growth, India is a poverty-driven country, which is also leading to the growth of beggars in the country. It is well settled that the right to life is the right to live with dignity and with necessities of life required for it.

In order to prevent the social evil like beggary, JJJS has been taking proactive steps since 2017. Through the SSEPD Deptt., Govt. of Odisha sponsored project “Outsourcing of Designated Functions of SSEPD Deptt.” JJJS identifies hundreds of such beggars in Boudh & Raigada district and provided assistance for their rehabilitation. Residential Rehabilitation Centres have been established at Boudh & Rayagada districts of Odisha 30 beggars each. Under this project managed from our own resources services like food, healthcare, clothing, vocational training, recreational services etc. are being provided.

## **ENSURING MINIMUM HEALTH & HYGIENE FOR RURAL MASS :**

### **PROMOTION OF AYUSH METHOD OF TREATMENT**

AYUSH, an alternative medical treatment, stands for Ayurveda, Yoga & Naturopathy, Unani, Siddha, and Homeopathy. The therapies involved in AYUSH treatment are backed by ancient medical sciences and have shown positive results when it comes to the treatment of diabetes, hypertension, and so many more. While the AYUSH treatment may not offer instant results this method of treatment is now preferred by thousands of people from all over the world as it is cost-effective as well as offers several benefits.

In order to provide benefit of AYUSH system of treatment to the general people we have been implementing a project involving AYUSH system of treatment and during the year adopted a G.P. in Rayagada district for the purpose. During the year 884 nos. of patients were provided with treatment for various diseases like Respiratory Tract Infection, skin diseases, diseases relating to digestive system etc. free of cost. The intervention attained its objectives as it helped the targeted patients in recovery from various ailments without any side effects. We are in the process of availing assistance from Govt. of India for the purpose.

## PROMOTION OF MODERN AGRICULTURE

Farming is an integral part of the Indian economy. With technological advancements and improvements in various structures, there has been a gone debate between traditional approaches to farming and modern approaches to farming which leaves the farmers and consumers stuck to choosing what over which? Agriculture is the industry that provides food, which is the most basic human necessity. Agriculture was closely associated with civilizations all over the world, and international economies were predominantly agricultural during the post-industrialization period.

Considering the fact that the economy of our state, Odisha mainly dependent on agriculture and allied activities for their livelihood hence the development of agriculture would be the basis of the development of the state. Hence Juba Jyoti Jubak Sangha is giving due emphasis to promote sustainable agriculture practice in its area of operation especially in the districts of Kalahandi, Subarnapur, Boudh and Gajapati. Also we are strongly endorsing the practice of lab-to-land in agriculture, which has been a part of Government's initiative in technology dissemination, participatory planning, value addition, demonstrative farming and marketing of produces. Apart from it, it has put effort in empowerment of farming community and capacity building of farmers.

Also we are promoting organic farming which is a holistic production management system based on basic principle of minimizing the use of external inputs and avoiding the use of synthetic fertilizers and pesticides to ensure sustainability of agriculture. Activities in this effort include:

- Awareness generation among farmers on the benefits of organic farming
- Imparting training to farmers on vermin-compost and other solid and liquid manures





- Demonstration of organic farming

The organization has worked for safeguarding the traditional knowledge of agriculture, particularly of tribal communities, relating to organic farming, preservation and processing of food for nutritional and medicinal purposes. People have realized the advantages of organic agriculture. It has increased farm productivity substantially.

## **PROMOTION OF HORTICULTURE**

Horticulture is the science and art of the development, sustainable production, marketing and use of high-value, intensively cultivated food and ornamental plants. Horticultural crops are diverse, including: Annual and perennial species, Fruits and vegetables, Decorative indoor plants and landscape plants. Considering the fact that horticulture helps in diversification of crops which enrich the soil after harvest of grains and gives better benefit to farmers than the former. Hence is promoting horticulture especially in wastelands with low availability of water.



Our organization has been giving due emphasis in extension of horticulture in all the districts of Odisha identifying potentiality of different crops in different areas like flower in Ganjam, Jackfruit in Keonjhar. The farmers are being provided technical assistance for selection of crops to suit their land, use of latest variety of seeds, modern farming techniques, organic inputs, IPM etc. to enhance production as well as productivity. Disseminating knowledge on various schemes with subsidy and how to avail it has been the integral part of our promotional initiatives. The farmers are now being attracted to horticulture



due to better return and reduced risk of loss compared to the traditional farming. Also our organization is availing the License for supply of Certified seeds, fertilizers (Both Chemical and Organic), Insecticides under the Department of Agriculture, Govt. of Odisha in order to make available proper input at subsidized rate for the benefit of the farmers. Farmers Producers Organization have been formed to promote farmers wellbeing through Cooperative System based on the guidelines of Cooperation Department, Govt. of Odisha.

## **PROMOTION OF FARMERS PRODUCERS ORGANIZATION (FPO)**

Our organization has taken a revolutionary step in promoting Farmers Producers Organization involving farmers of Cotton, millet, vegetable, floriculture, mushroom, spices like turmeric & Ginger etc. in throughout the state of Odisha. During the year 85 nos. of Farmer Producers Organization (FPO)



have been formed. Through this initiative thousands of farmer involved in cultivation of various crops as above have been brought under Cooperative system through FPO. Each FPO has been registered under Odisha Cooperative Societies Act of 1962. and each of them would be benefited with end-to-end services covering almost all aspects of cultivation from providing inputs, technical services to processing and marketing of the agricultural produce

Our organization is aiming to form around 300 nos. of FPOs in the state of Odisha. Through this initiative lakhs of farmers would be benefited in the long run. This is one of the ambitious programme of our organization as it will strengthen the socio-economic status of the farmers which is the backbone of our state's economy.



Our organization is on process to work for the development of the farmers through Odisha State Agricultural Marketing Board (OSAMA). Efforts are on in promoting marketing of agricultural produce of the farmers through Farmers Producer Orgnaization.

## **PROMOTING EDUCATION IN BACKWARD AREAS**

### **EDUCATIONAL COMPLEX FOR SC/ST GIRLS**

In our society especially in rural areas girl child education is not a priority at all. If we take the case of tribal girls then we will observe that they are the most neglected ones where the literacy percentage of girl child education is even less than 5-10% in some districts of Odisha. In order to increase percentage of girl child education Govt. of India, Ministry of Tribal affairs has been running a scheme called Strengthening Girl Child Education in low Literacy Pockets

Our organization has been running an Educational Complex for ST girls in Rayagada district of Odisha. The project is being run with our own resources since last three years. The project is providing education to the ST girls free of cost project intervention in tribal dominated Kalahandi district of Odisha we observed that the children from ST families are unable to pursue education due to a no of factors starting from poverty to lack of interest/negative attitude of the parents, lack of opportunities etc.. In order to provide quality primary education to the girls belonging to ST community in low literacy pockets Govt. of India, Ministry of Tribal Affairs has been managing the scheme called: "Strengthening Education in Low Literacy Pockets". Our organization has been managing school called as Educational Complex at Rayagada district since 2019-20 from its own resources. The district has a very low rate of female literacy at 14%.

These children are getting education based on school curriculum with a holistic approach for all-round capacity building of the girls in every respect like sports, culture, social work, physical well-being, life skill etc., free of cost to make them capable enough to compete with others in the society and live a respectful living. In addition to this, the students are provided various vocational training to make them employment-ready whenever they complete their academic career.

## **SENSITIZING THE RURAL MASS ON KEY ISSUES: CONSUMER AWARENESS PROGRAM**

Consumer Awareness is a demonstration of ensuring the purchaser or buyer knows about the data and information about items, products, administrations, and buyers' privileges. Consumer awareness is significant with the goal that purchasers can settle on the best choice and settle on the ideal decision.

In order to address the various issues concerning the consumers, JJJS organized five nos. of awareness programmes involving all the stakeholders like volunteers, school teachers, school children, SHG members etc. in Rayagada block of Rayagada district. Concerned Govt. officials and volunteers from the local NGOs were involved in the program. The resource persons educated the participants regarding consumer protection laws, its application and how to protect themselves from the greedy businessmen. Leaflets were distributed highlighting the different consumer laws, consumer protection councils etc. among the participants who were requested to disseminate the knowledge in their respective areas to safeguard the common interest of the consumers.



## **ENVIRONMENTAL AWARENESS**

Environmental awareness is having an understanding of the environment, the impacts of human behaviors on it, and the importance of its protection. Millions of acres of forest are cut down for industrial benefit, such as large scale farming, oil mining, and the production of paper goods. Deforestation causes wildlife and biodiversity extinction because the loss of habitat threatens many species' existence.

Environmental Conservation is the practice of preserving the natural world to prevent it from collapsing as a result of human activities, such as unsustainable agriculture, deforestation and burning fossil fuels. Side effects of these practices include toxic air, plastic pollution, destruction of natural habitats and most urgently, climate change. Scientists warn that if we don't act soon, this will lead to an even further increase in natural disasters, rising sea levels and extreme weather,





resulting in collapsed ecosystems, mass extinction of wildlife, food scarcity and global displacement of people.

We at JJJS are proactively involved in checking the environmental degradation JJJS during the year organized awareness programmes in Rayagada, Bisam Cuttack block of Rayagada district of Odisha involving folk plays. Also during the year on report a decentralized nursery was raised at B.M. Pur under Subarnapur district of Odisha in which 25,000 plant seedlings were raised and then distributed to the local inhabitants free of cost for planting in their own backyard. Such an initiative will help the people to meet their fuel wood and fodder demand to some extent in due course and help in reducing the load on natural forest resources.

### **PROMOTION OF TRADITIONAL CULTURE/ARTISTS**

Odisha is a confluence of the Aryan, Dravidian and Adivasi cultures. Most festivals in the state bring out some part of these cultures and celebrate their religion by way of festivals which span out the entire year. There are festivals that are common, but the celebration remains unique to a region.



Odisha has a glorious tradition of music. The figures or dancers and musicians carved on ancient temple walls, speak of Odisha's rich musical heritage. Odissi Music is a classical form consisting of all the necessary ingredients common to Hindustani and Karnatic Music. Odissi sangita is a synthesis of four classes of music, i.e., dhruvapada, chitrapada, chitrakala and panchal, described in two treatises namely, Sangita Sarani and Sangita Narayana written in the early 19th century.

Realizing the importance of the cultural programmes our organization has been giving due emphasis to cultural activities since long. During the year a series of cultural programmes were organized at B. M. Pur under district in which folk groups performed different songs and dances. Various cultural programmes were organized which is now on the verge of extinction. The programme was enjoyed by thousands of people around the block.

### **WELFARE OF CHILD/WOMEN LABOUR**

The survey reports of working children as young as five to nine years indicates that around 0.3% children aged five to nine years in India and 0.5% in Odisha are working. It reported that in the five to 14 year age group, Odisha has 4.9% working children as compared to 3.3% in India.

Substantial proportion of the child labour in the state is engaged in agriculture and allied activities in India. This sector alone account for over two thirds of the child employment. Manufacturing sector account for more than 15 percentage of



child employment followed by trade, hotels and restaurant.

To rehabilitate the child labour engaged in hazardous activities JJJS rescued child laborers from different professions and admitted in the child labour schools. In the said schools meant for their rehabilitation the child labours are receiving elementary education, vocational skill training. They are being provided free nutrition & healthcare services to keep themselves healthy and fit.

Also an educative programme was organized for women laborers at Boudh in which the various welfare issues like labour laws, labour welfare initiatives, various welfare schemes were discussed and knowledge was disseminated to them.

### **PROMOTION OF MINORITIES**

All the people from our country other than Hindus are treated as minorities. Government is adopting different welfare measures from time to time for uplifting their status in the society so that social equity can be maintained. Juba Jyoti Jubak Sangha has also been promoting several measures in promoting the development of these unprivileged sections of the society.

Since long Juba Jyoti Jubak Sangha has also been promoting several measures in promoting the development of these unprivileged sections of the society. During the year two nos. of Leadership Training Programme was organized for Minorities at J. K. Pur of YRayagada district. Also in the training programmes the beneficiaries from the Minorities sections were given priority. In all of our projects beneficiaries hailing from these sections are being given first priority. We are also in the process of availing assistance from the concerned Ministries of Government of India for different projects for welfare of these sections of the society.

### **CAREER COUNSELLING**

In order to assist the students and educated unemployed youths hailing from rural areas especially BPL tribal and minorities families JJJS has been managing a Career Counseling Centre at Sonepur under Subarnapur district of Odisha since long. Under this initiative students and other educated youths from rural poor and tribal families and from Minorities (Mainly Muslims & Christian) are being assisted in providing counseling and assistance for applying for jobs, applying for various job oriented technical courses, for availing various scholarships through online process. During the year 286 nos. of such students and educated youths have been benefited. This activity is being managed by the organization from its own resources.

### **PISCICULTURE**

In order to enhance the economic resources of the organization to support the activities our organization have been promoting Pisciculture in five ponds at Kesinga under Kalahandi district of Odisha. Sixteen nos. of poor households with experience in the field of fishery were engaged to earn their livelihood. This initiative is being used as a center for extension of pisciculture in the area by providing training to the aspiring farmers.



## **CONCLUSION**

JJJS as a nonprofit making voluntary agency has been working within certain limits and at its best to achieve the stated objectives with the help of its work force. It can do better if further cooperation and assistance is provided to it in a continued manner. At last we hope to get love and affection and cooperation from all those associated with us in any way which will encourage us to work better for the society.
